Parking Enforcement

Employees must display their permit at all times. Failure to do so can result in a citation from the Parking Coordinator. Your permit is registered to your name and vehicle in the Parking Management system. If you lose your permit, call or email the Parking Coordinator immediately. Effective 08/13/2018, replacement of a lost Permit or access card will be ten dollars. Permits and cards are the property of TCFMD.

Employees are asked to maintain an accurate account of their vehicle license plates that are permitted to park within our zones via Travis Central Website. Click on the Parking tab located under Quick Links and make your selection. If a license plate is found in a zone that is not listed on this site, it is considered a violation.

If the vehicle is found in violation, the operator will be asked to take corrective action immediately. Repeat offenders can lose parking privileges indefinitely. The basic enforcement procedure conducted when addressing repeat violators is:

- 1st Violation citation from the Parking Coordinator
- 2nd Violation citation and email sent to his or her immediate supervisor
- 3rd Violation citation and banning employee from County parking facilities indefinitely

Towing is enforced after the 3rd violation.

Granger Garage--located behind Granger Building, at 12th Street and Guadalupe St.

Enter the garage from the Entrance off of Guadalupe Street. Drive straight ahead until you must turn left. Then turn left, and left again in the crossover area.

Garage is designed to be driven on the Left Side. So, always stay to the left as you ascend and when you descend to leave. There is only one exit, and that will put you on to 12th Street. That side of the street is one way, so you must turn right (East) on 12th Street where you will approach the intersection with Lavaca Street.

Follow all posted signs in the garage. Speed limit, stop signs, right turn prohibited, etc. There are a total of seven floors to this garage. Use caution in the middle crossover areas as other vehicles *may be* crossing at the same time but going in the opposite direction and staying to their left.

Do not park in the spaces marked Business Fleet Parking Only, located on the First and Third levels.
